### **Vice-Chair's Report:**

- Fall General Meeting topic ideas - will discuss at August's meeting when there is more board member input
- Bend 2030 Vision - Cassie may become our communication link between the 2030 board and RWNA, since she is involved in both organizations (Neighborhood Associations are listed in the action plan as a resource to the 2030 vision)
- Code enforcement will e-mail the NA chairs with the 26-page Code Enforcement Manual (not available on the City's website)
- City of Bend General NA meeting in July touched on the Illegal Fireworks taskforce, and had Erik King (City Manager) as guest speaker. He says City Council is looking to do more outreach to the community in efforts such as:
  - An "open to the public" work meeting scheduled for September
  - Meet in Spring '09 in one or more of the NA neighborhoods for a "town hall" meeting style
  - Choose a business in Bend to have a "coffee with the councilors"

- General Funds for FY08-09 just reset with a \$4,981 budget. We will try to save on General Meeting mailing costs by utilizing e-mail more, and will save significant expenses without a Spring General Meeting
